

# TOWN OF DAYSLAND

## BYLAW No. 2018-639

### A MILL RATE BYLAW OF THE TOWN OF DAYSLAND, IN THE PROVINCE OF ALBERTA

#### THE PURPOSE OF THIS BYLAW IS TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF DAYSLAND FOR THE 2018 TAXATION YEAR.

**WHEREAS**, the Daysland Town Council has adopted detailed budget estimates of municipal revenues and expenditures at the May 22<sup>nd</sup>, 2018 council meeting, and;

**WHEREAS**, the **estimated expenditures and transfers** set out in the budget for operations for the Town of Daysland total **\$2,469,503 and \$583,800 for capital work.**

**WHEREAS**, the **estimated 2018 municipal revenues and transfers** from all sources other than property taxation is estimated at **\$1,406,647**, for operations exclusive of amortization is to be raised by general municipal taxation and;

**WHEREAS**, the following table shows the assessed value of all lands and improvements, municipal levies, requisitions, and respective tax rates for taxable properties within the Town of Daysland;

1. **THAT**, the Chief Administrative Officer is hereby authorized to levy on the assessed value of all land and improvements as shown on the assessment roll for the Town of Daysland using the **2018 Mill rates** as shown in this bylaw on the above table.



3. This bylaw comes into force and effect on the day of final passing thereof.


